**QUALITY:** All items ordered will be supplied in accordance with MIL-I-45208 or ISO 9002 standards, or higher. Items supplied shall meet the requirements of all applicable technical specifications and documentation (drawings, specification, standards, etc.). It shall be the sole responsibility of seller to ensure that work is performed in a manner consistent with purchase order instructions and technical specifications. Where no specific requirements are stated, good industry and craftsmanship practices shall be observed. All life limited items must have 75% of the life remaining upon receipt by Maverick Aerospace, LLC Life limited items will be identified with the manufacturer's name, cure date, batch or lot number and shelf life or expiration date.
